My first job ever was when I was 14 years old and worked in a veterinary practice assisting with TB testing of cattle. My dad worked in Telecom Eireann which at that time was a civil service job. From his experience, I knew that the civil service is a reliable career.



I graduated with an Undergraduate Degree in 2008 and a Graduate Higher Diploma in 2009. I worked briefly as a freelance online content writer in Buenos Aires, Argentina. I returned to Ireland for a short time and worked in retail. I obtained a CELTA qualification in 2012 and moved to Seoul, South Korea to teach English. I was there for 1.5 years, I then moved to Hangzhou, China for 1 year and subsequently Tokyo, Japan for 1.25 years.



I decided to return to Ireland in 2016. Almost immediately I applied to the open Clerical Officer competition. In the meantime, I worked in retail. I began in Publicjobs.ie in January of 2017. On my first day, I was encouraged to apply for the Executive Officer competition.





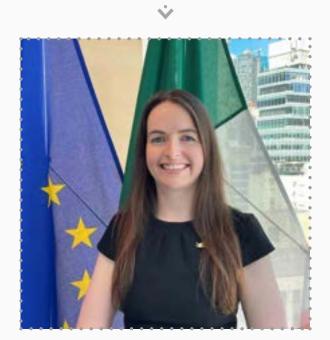
In September 2017, I was appointed as an Executive Officer in the Department of Foreign Affairs. I worked in the HR section.
I was interested in becoming a Third Secretary because of my experiences living abroad.
I truly could see the real world impact of Irish representation abroad. Also, since childhood, I wanted to become a writer and diplomats certainly do a lot of writing!



In mid-2018, I was approached to become a 'Pathfinder' – the project manager for opening our new Embassy in Bogotá, Colombia. I applied in 2017 to the Third Secretary competition but was not successful at final interview. I applied again in 2018. I was appointed a Third Secretary in March 2019 while still in Colombia.



I am Deputy Consul General which means
I have responsibility for oversight of all
operations in the Mission including health and
safety, security, financial reporting and other
governance matters. I also oversee citizen's
services such as consular assistance and
passports.





Aside from this I am responsible for stakeholder engagement with the Irish community. I also promote Irish culture and economic interests. I oversee all our public diplomacy on social media.



The skills required are an interest in other people. I would say that you have to enjoy meeting new people and of course going to new places. Language skills are important as in an interest in writing.
